NATIONAL OSTEOPOROSIS FOUNDATION RELEASES NEW CLINICAL RECOMMENDATIONS FOR LOW BONE MASS AND OSTEOPOROSIS INCORPORATING ABSOLUTE FRACTURE RISK

NOF's new guide dramatically alters the way patients, both men and women, are evaluated and treated and better identifies those at risk for fractures from low bone mass or osteoporosis. Guide represents a major breakthrough utilizing Absolute Fracture Risk methodology as the basis for making treatment decisions in patients with low bone mass or osteoporosis.

Washington, DC – The National Osteoporosis Foundation (NOF) is releasing its new Clinician's Guide to Prevention and Treatment of Osteoporosis to help U.S. healthcare providers make better treatment decisions and assess fracture risk for patients with low bone mass or osteoporosis. The new information in the Guide is based largely on a report (also being released) from the World Health Organization (WHO) detailing the WHO algorithm (FRAX®). This algorithm estimates the likelihood for a person to break a hip or other major bone due to low bone mass or osteoporosis over a period of 10 years.

The updated Guide, with the application of absolute fracture risk, provides an improved basis for clinicians and patients to make decisions about osteoporosis prevention and treatment. The Guide is also available on our website www.isprm.org

Diagnosis of fracture risk becomes much easier, bringing benefits to those at risk and cost savings

The International Osteoporosis Foundation (IOF) has welcomed the launch of the World Health Organization (WHO) technical report, Assessment of osteoporosis at the primary health care level¹ and the FRAX™ website, as major steps towards helping health professionals worldwide to identify more easily patients at high risk of fracture for treatment.

"The new WHO report and its related FRAX™ tool which predicts the risk of osteoporosis fracture using clinical risk factors will be of considerable use to health care professionals and policy makers throughout the world, particularly in places where there are few DXA machines. We know that early diagnosis and treatment can save precious healthcare resources so we see the launch of these two assets as a very important milestone in the fight against osteoporosis."

Assessment of osteoporosis at the primary health care level, authored by Prof. Kanis et al., was released on February 21, 2008. It is a technical report based on epidemiological and health economic analyses of population-based cohorts worldwide. A practical tool, named FRAX™, www.shef.ac.uk/FRAX has been developed to predict the ten-year risk of fractures.

IOF RECOGNISES ESCEO EUROPEAN GUIDANCE FOR OSTEOPOROSIS DIAGNOSIS AND MANAGEMENT

A comprehensive guide to applying new FRAX™ tool and WHO technical report in European daily practice

The International Osteoporosis Foundation (IOF) has welcomed the recently published paper European guidance for the diagnosis and management of osteoporosis in postmenopausal women¹ from the European Society for Clinical and Economic Aspects of Osteoporosis and Osteoarthritis (ESCEO).

This paper constitutes a roadmap for European countries to practically implement the new FRAX™ tool based on the WHO technical report, Assessment of osteoporosis at the primary health care level^{2,3}. The European guidance, published in Osteoporosis International, is a critical review of diagnostic methods, treatments and their monitoring options. It also shows case-finding strategies supported by health economic data.

IOF sees the ESCEO guidance as a positive move towards using the FRAX™ algorithm in daily practice. The WHO report and FRAX™ tool, released on February 21, 2008, help health practitioners to better understand the new paradigm for diagnosis and management of people at risk of developing fragility fractures.

In this regard, there will be a FRAX™ exhibition booth at the forthcoming ECCEO 8 Congress in Istanbul, Turkey, to be held at the Grand Cevahir Hotel & Convention Center. Participants will have the opportunity to have their 10-year fracture risk calculated, based on their geographic origin and individual risk factors. As a next step, the ESCEO paper can contribute with guidance on how to manage or monitor their condition, in the most rationale and cost-effective way.

Professor Jean-Yves Reginster, President of ESCEO, noted, "The ESCEO European guidance is convergent with the WHO report on how to assess and treat postmenopausal women with or at risk from osteoporosis. Moreover, cost-effectiveness analyses which illustrate scenarios based on a UK setting provide a starting point for health policy makers and health care providers to develop national guidelines on diagnosis and intervention thresholds."

The ESCEO guidance is very timely, as across Europe, osteoporosis is a major public health problem with serious medical and economic impact. In 2000, throughout the region, there were an estimated 620,000 new hip fractures, 574,000 forearm fractures, 250,000 shoulder fractures, and 620,000 spinal fractures in men and women aged 50 years or over, accounting for 34.8% of such fractures worldwide⁴. There are more than 2.7 million osteoporotic fractures in men and women in Europe at a direct cost of 36 billion euros⁵. It is estimated that by 2050, direct costs related to hip fractures will increase to 76.7 billion euros⁶.

The 1st Iranian Congress of Intervtional physiatriic pain managment was hold at December 20, 2007 in Tehran, Iran. This congress was organized by Shahid Beheshti university, M.C in collaboration with Iranian socity of physical and rehabilitation medicine, Dr Seyed Mansoor Rayegani Associte prof. Of physical medicine and rehabilitation was scientific secretary of the congress. The congress covered many topics of pain medicine including: definition, pathophysiology, physical modality measures, interventional procedures and pharmacotherapy. These topics were presented by invited speakers from different Disciplines including physiatry, Anestlesiology, Neurosurveyey, Neurology, pharmacology, nutrition and Psychology. Dr Ali Nemat, coordinator of pain medicine program of South California University was invited as keynote lecturer. More then 200 participants from different disciplines participated in the congress.

REHAB DUBAI 2008 WITH STRONG LOCAL AND INTERNATIONAL PARTICIPATION

Under the patronage of H.H Sheikh Hamdan Bin Rashid Al Maktoum, Deputy Ruler of Dubai Minister of Finance, the 6th edition of Dubai International Rehabilitation Forum and Exhibition - Rehab Dubai 2008 opened 12th March 2008 at the Dubai International Convention and Exhibition Centre.

H.E Mariam Mohammed Khalfan Al Roumi Minister of Social Affairs and H.E. Werner Van Cleemputte Executive Director International Society of Physical and Rehabilitation Medicine (ISPRM) graced the inaugural ceremony. The UN Resident Coordinator/UNDP Resident Representative in United Arab Emirates Dr. Khaled Alloush will also be present. Mr Thani Jumma the chairperson of the organising Committee and chairman of Dubai Club for Special Sports revealed this in a statement today. The Department of Tourism and Commerce marketing, Dubai Conventions Office is the official supporter.

Since its inception, Rehab Dubai has raised the profile of disability, awareness and rehabilitation issues in the UAE and in the Middle East region. Al Madani added, 'Rehab 2008 will give manufacturers, suppliers, traders and distributors of rehabilitation equipment the opportunity to reach new markets in a short period of time though exhibiting and meeting Government officials, purchasing officers, decision makers and representatives of regional rehabilitation hospitals, clinics, centres and institutions.

Rehab will display the latest rehabilitation products and services from different parts of the world. Rehab Dubai is the only platform in the Middle East that will bring together investors, manufacturers, suppliers and products and services providers and consumers under one roof. B2B meetings and direct face-to-face contacts will be arranged, which will result in exploring new markets and conclude long-term deals,' Mr.Madani said.
